## **Completing a Monthly Remittance Form**

The monthly remittance form is filled out each month for all cattle bought the previous month. You have until the 15<sup>th</sup> of the following month to send in the form and money. EXAMPLE: You buy cattle in January; you have until February 15<sup>th</sup> to send the form and money.

- #1. a) For businesses-Federal Identification Number, or whatever used to file with the IRSb) For individuals-Social Security Number
- #2. Company name, or your own name if individual
- **#3.** Fill in information from where you do business; business address if company, home address if individual
- #4. The month in which cattle were actually bought.
- #5. The state where the cattle resided for at least 30 days prior to the sale.
- #6. Total number of cattle purchased.
- #7. Cattle for which you received a non-producer status form, or purchased from an auction market.
- **#8.** This is the number of animals on which you collect checkoff dollars. It is the total number of animals (#6) minus those not assessed (#7).
- **#9.** This is the total amount of money owed on cattle per state of origin. Multiply the number under #8 times \$1.00.
- #10. This is the grand total for the entire month. Write a check for this amount.
- **#11.** Send the **white and yellow copies** along with the check to this address. Keep the pink copy for your records.
- #12. Write today's date. Note: Failure to remit the checkoff assessments by the appropriate date will result in an assessment of a late payment charge of 2% per month compounded monthly until amount is paid in full.
- #13. Print your name and title, and sign where appropriate.

Failure to comply with the Beef Promotion Act and Order is subject to two penalties:

- a) Civil penalty of up to \$5,500 per violation.
- b) Fraudulent use of a government form a fine up to \$10,000 and imprisonment of up to 5 years.
